CF requests \$2,927,830 to construct a Science and Technology Building to support the Science, Nursing, Technology and Engineering programs on its South Sarasota County campus. This new facility will create science laboratory work stations to support growing enrollment on the SCF Venice Campus (4 percent in Fall 2019), growth in the Gator Engineering at SCF program (increased to 28 students in 2019) and the addition of the SCF Collegiate School (400 students in grades 9-12 by 2022).

This new 8,913-square foot building will create 100 student laboratory stations, greatly increasing the number of courses available and create access for students, specifically in the Science, Nursing, Technology and Engineering programs. Facility will also support SCF on campus dual enrollment science courses and students in the SCF Collegiate School.

This project will allow the College to enhance the student academic experience and respond to community needs. It will help SCF prepare students to be successful in the local workforce or at a state university. The lab facility will support prerequisite courses for nursing (485 annual nursing job openings in region) and engineering (118 annual engineering position openings in region).
