End Human Trafficking, Inc. is the direct support organization (DSO) of the Statewide Council on Human Trafficking, pursuant to Section 16.618, Florida Statutes. During FY 2019-2020, a nonrecurring amount of \$250,000 was appropriated from the Department of Legal Affairs for implementing and administering the DSO and for developing training and information services with the Florida Forensic Institute for Research, Security, and Tactics. The cost for the training and awareness course was \$143,000.
