This project is the design phase of a wastewater collection system in the Centerville Trace neighborhood, to be connected to the City of Tallahassee’s central sewer system. Converting wastewater treatment in the Centerville Trace subdivision (157 parcels) to advanced wastewater treatment will reduce the total nitrogen load by 3,100 pounds per year.
