LSSC South Lake campus was developed in 1999 with two instructional and administrative buildings totaling 100,000 square feet, followed by 65,000 square feet joint-use library in 2010, and 51,320 square feet science health building in 2017. The four buildings support an LSSC enrollment of 2,228 students, an increase of 15.6% since 2012. The campus also includes students from the University of Central Florida and Lake-Technical College and dual enrollment students from Lake County Schools.
