This model can then serve as a pilot of state innovation and replication.

Through a partnership with Pinellas Education Foundation and local employers, SCAP matches students and local business partners for summer internships/apprenticeships. Services/commitments include: Students work for a stipend equivalent to minimum wage for 20 hours per week. Students may be eligible for high school credit through the diversified education program. Pinellas Education Foundation (PEF). The PEF will recruit businesses to provide internships/apprenticeships for students.
