This project will help to balance and improve flood control in the Village by increasing the quantity of water that the drainage system is able to support. We will also help to protect the verified impaired waters of Biscayne Bay by allowing rainwater from the Village's roadways to be treated prior to entering directly into the Bay. Once the drainage system is repaired, we will protect this investment by installing tide flex valves at the end of each outfall.
