Jacksonville is ranked 4th in the nation for highest pedestrian deaths, according to National Complete Streets Coalition. This project will install approximately 1,924 new countdown heads at 292 state intersections. The goal is for the countdown heads to reduce pedestrian crashes by 25%.
