Funding will provide the City of Winter Springs the opportunity to construct multiple on- and off-line stormwater storage facilities along Gee Creek, which is a tributary to Lake Jesup. Lake Jesup is a recreational lake located in the Middle St. Johns Basin, which is impaired for both nitrogen and phosphorus. The completion of these projects will provide for additional storage in the Gee Creek floodplain and also provide water quality benefits to help reduce nutrient loading into Lake Jesup.
