Per FDEP's PLSM Model being utilized for the evaluation of potential nutrient load reductions as part of the Loxahatchee River Reasonable Assurance Plan (RAP), the proposed project is predicted to reduce Total Nitrogen (TN) by 64.62 lbs/yr and Total Phosphorus (TP) by 5.65 lbs/yr. through the creation of this secondary outfall location for the basin approximately 10% of the runoff will be diverted from within the RAP boundary. This will provide added benefit beyond the nutrient loading reductions
