Students will all be adults ages 16 and above who are reading below the 9th grade level. Learn to Read will provide small group instruction, one-on-one tutoring and access to online lessons and exercises.

Students will receive an initial assessment and educational plan, participate in small group lessons, online learning activities, and then individual tutoring from a trained volunteer. Participating adult students will be from the Northeast Florida area and will be directly provided reading, writing and basic math instruction to raise their overall reading level.
