To convert a portion of the wastewater system from sewer force-main with grinder stations to a more economical gravity sewer system. By replacing the pressure sewer system with a gravity system, the existing grinder pumps can be removed from each house, thus reducing energy consumption and repeated maintenance of the grinder pumps. The topic of the costly maintenance of these grinder pumps has been a point of contention between the citizens that own the pumps and the City of Bristol.
