The project scope includes design, permitting, right-of-way acquisition, and construction of a 3.3 mile, eight-to-twelve foot wide trail within the City of Sanford and Seminole County.

This shared use path will commence at Sanford’s Riverwalk and progress along Mellonville and Celery Avenues for 2.5 miles. It will conclude at a trail connection near Celery Avenue and State Road 415. Increased trail connectivity options co
