The technology software developed is a web-based smart phone app, Community Based Services (CBS) which measures the deployment of human service activities administered at the community based level specifically designed for faith and community based organizations servicing indigent populations, particularly those residing and receiving services in impoverished communities.

The direct services that will be provided are based on the evidence based "Communities That Care" model of prevention / intervention services to high-risk populations. The CBS app will monitor, capture and process utilization data of services rendered in 4 categories, 1. Individual, 2. Family, 3. Education & 4. Community. The CBS app serves as COMSTAT data management and strategic instrument in managing service utilization, frequency, individual progress or regression for youth and families.
