The City of Lauderdale Lakes has a deficiency of four School Resource Officers to staff all of the schools in the City both public and charter schools. There is a deficiency of four School Resource Officers at an approximate cost of \$640,000. The Broward School Board provides approximately \$49,000 in funding for each officer and the City will contribute \$31,000 for each officer. Our request to the State of Florida is to fund 50% of the \$640,000 needed to hire SRO's or \$320,000.
