Funds to build, or purchase and renovate, a 15,000 sq. ft. facility for the Pace Hernando Center, and Pasco and Hernando Reach programs that operate 250 days per year and serve approximately 250 girls at risk of justice system involvement in FY 2019-20. Pace Hernando is currently housed in portables located on the J.D. Floyd Elementary School property as a temporary location. The facility will include a safe location for classrooms, counseling, and other school safety features.

Currently, Pace Hernando and Pace Pasco have an MOU with their school districts allowing Pace Reach to provide counseling and wrap around social services to girls in their schools. Pace Hernando currently has an agreement with JD Floyd Elementary School for use of their portables as a temporary location.

The FL Department of Juvenile Justice Services Continuum Analysis (SCA) identifies a specific need for mental health, and transition and independent living services and life skills for youth in Pasco County. Hernando County identifies Pace Center for Girls as a program

providing services to girls in the area. Both counties identify transportation as a barrier to services, something addressed by our Pasco and Hernando Reach programs.

17. Will the requested funds be used directly for services to citizens?

17a. What are the activities and services that will be provided to meet the purpose of the funds?

The building will be utilized to serve approximately 250 girls annually who are at risk of juvenile justice system involvement. Girls receive wrap around social services such as therapy, counseling and life skills. Girls in the day program also receive their full academic school day. Services are provided in a trauma informed, gender responsive and strengths based environment.

17b. Describe the direct services to be provided to the citizens by the funding requested.

The building will house a Pace Center and central operations for Pace Reach, providing comprehensive wrap around social services and the full academic school day to approximately 100 girls at risk of delinquency through our Pace Center and comprehensive wrap around social services to an additional 150 girls annually through Pace Reach in Hernando and Pasco counties. Case management for the girl's family is also provided to ensure a stable home environment.
