These additional I/I flows take up the capacity of the City's waste water treatment plant and results of additional expenditures to treat the higher wastewater plant flows. There has been overflows during heavy rain events which has been reported to FDEP. The City desires to conduct a Sanitary Sewer Evaluation Study.
