The Town is requesting to purchase one fire rescue truck as the exiting vehicle was purchased in 2000 and is over 19 years old, exceeding its lifespan. This specialized equipment is necessary for emergency response and protection of property. Without a replacement fire ladder, the Town must rely on mutual aid from neighboring municipalities/agencies, impacting response times and ISO ratings. The Town has a pronounced need to replace and upgrade its public safety equipment.
