The Washington County River Road Project will include 2.5 miles of paving improvements to connect the existing 14 miles of CR-284 to Pate Pond Road. The project has heavy traffic and will complete the paving of the entire length of CR-284. The FDOT recently completed bridge construction over Fish Branch and the new pavement will tie into the recently completed bridge project. The 22' wide road will meet minimum Greenbook standards and will improve the negative impact on adjacent wetlands.
