The City of Mexico Beach was significantly damaged by Hurricane Michael in October, 2018. Much of the City's infrastructure was heavily damaged. As the City rebuilds and recovers there are portions of the infrastructure that have been strained/damaged but are not eligible for FEMA funding. The City has identified a 4,000 linear foot section of old 2 inch water main that must be replaced due to age and inadequate capacity. Funds would be for construction to replace this water main.
