Provides funding to Sacred Heart Bay hospital that will enable the hospital to bring the Obstetrics service line back to the hospital. Before Hurricane Michael, Sacred Heart Bay was delivering 300 babies a year and the hurricane demolished the towers where the OB unit was located. The rebuilding plans do not currently include bringing the OB unit back to the hospital. With only one other hospital delivering babies in the County, the community feels another provider is needed.
