SJRWMD is currently constructing a weir just east of the culvert which will redirect the flow of water in the M1 canal to the west towards the culvert. The existing culvert and bridge will be replaced with a new concrete culvert and new bridge for vehicles. This is one of only two roads which serve as access points to the Town.
