All parties have endorsed the program that will enhance service delivery.

24-hour a day staffing of firefighters to respond to calls for service in the region. Previously the all-volunteer fire department was responding to approximately 1/4 of the calls dispatched to. Currently we staff during daytime hours but with the new facility, we will staff the station 24/7.
