To adequately serve the northern area of Starke, the new bypass, and surrounding Bradford County with potable water and fire protection, a new water treatment plant will need to be constructed at the north end of the current city limits. This new WTP would have the initial capability of producing 1,500 gpm of flow and could ultimately be expanded to a peak pumping capability of 2,250 gpm. It would be connected to Starke's existing potable water system and would improve operating pressure.
