To provide a FDLE approved outdoor firing range and driving facility for the Manatee Technical College Law Enforcement Academy. The Academy provides the FDLE approved training for approximately 70 students per year and serves over 600 law enforcement officers in Manatee County. A 36-year old firing range and driving facility were condemned in 2016, forcing students and officers to resort to suboptimal alternatives for training, practice and continuing education.
