

**FIRST MODIFICATION TO AGREEMENT BY AND BETWEEN
HILLSBOROUGH COUNTY PUBLIC TRANSPORTATION COMMISSION
and
CORCORAN & JOHNSTON**

THIS FIRST MODIFICATION AGREEMENT, dated this 8th day of June, 2016, is entered into by and between the Hillsborough County Public Transportation Commission, a Florida Independent Special District, hereinafter referred to as the "PTC" and Corcoran & Johnston, a corporation existing under the laws of the State of Florida, hereinafter referred to as the "CONTRACTOR".

RECITALS

WHEREAS, the PTC and the CONTRACTOR entered into an agreement with an effective date of July 1, 2015 for the provision of government relation and lobbyist services in exchange for a negotiated annual compensation amount of \$120,000.00; and

WHEREAS, the PTC, at its regular meeting on June 8, 2016, and based upon the desire to continue the Agreement at the same terms and conditions, with the exception of consideration, exercised one of its two one (1) year renewal periods; and

WHEREAS, the parties, who anticipate a lesser need for such government relation and lobbyist services in the upcoming year, have agreed to a corresponding lesser annual compensation amount of \$96,000.00, for the provision of such services.

NOW, THEREFORE, in consideration of the mutual covenants and provisions contained herein, additional to those heretofore made, the Agreement is hereby modified as follows:


1. Article 3, Consideration and Payment, second paragraph, is modified to read:

"The CONTRACTOR shall be paid an Annual Flat Rate Fee of \$96,000.00 for services rendered. The Annual Flat Rate shall be paid in twelve equal monthly payments of \$8,000.00. The Annual Flat Rate Fee shall include all costs associated with performance of the CONTRACTOR including out-of-pocket expenses and travel expenses."

All other terms and conditions of the Agreement which do not conflict with this FIRST MODIFICATION AGREEMENT are hereby reaffirmed in their entirety. In the event of a conflict between the terms of this modification and the Agreement, the terms of this modification shall control.


IN WITNESS WHEREOF, the CONTRACTOR and the PTC respectively, have caused this modification Agreement to be executed by their duly authorized representatives.
