**FIRST AMENDMENT TO SERVICES CONTRACT
BETWEEN
THE CITY OF JACKSONVILLE
AND
THE FIORENTINO GROUP, LLC
FOR
STATE GOVERNMENT RELATIONS CONSULTANT SERVICES-
INFRASTRUCTURE INITIATIVES**

THIS FIRST AMENDMENT to Contract is made and entered into this 22 day April, 2016, by and between the CITY OF JACKSONVILLE, a municipal corporation existing under the Constitution and the laws of the State of Florida (the "CITY"), and THE FIORENTINO GROUP, LLC, a Florida limited liability company authorized to transact business in Florida with its principal offices at 31 West Adams Street, Suite 204, Jacksonville, Florida 32202 (the "CONSULTANT").

WHEREAS, on January 1, 2016, CITY and CONSULTANT made and entered into City of Jacksonville Contract No. 10179 (hereinafter the "Contract"); and

WHEREAS, said Contract has not been amended previously; and

WHEREAS, said Contract should be amended by revising the Contract Fee Summary, as reflected in **Exhibit "B-1"**, attached hereto and incorporated herein by this reference, and by increasing the maximum indebtedness by \$10,000.00 to a new not-to-exceed total maximum indebtedness of \$60,000.00, with all other provisions, terms, and conditions of said Contract remaining unchanged; now therefore

IN CONSIDERATION of the premises and the mutual covenants contained below, the parties agree as follows:

1. The above-stated recitals are accurate, true, and correct, and are incorporated herein and made a part hereof by this reference.

2. Section 2 of said Contract is amended by revising the Contract Fee Summary as reflected in **Exhibit "B-1"**, and as amended shall read as follows:

"2. Compensation. CONSULTANT will be paid by the CITY for the Services in accordance with the Rate Schedules attached hereto as **Exhibits 'B' and 'B-1'** and incorporated herein by this reference."

3. Section 3 of said Contract is amended by increasing the maximum indebtedness by \$10,000.00 to a new not-to-exceed total maximum indebtedness of \$60,000.00, and as amended shall read as follows:

“2. **Maximum Indebtedness.** As required by Section 106.431, *Ordinance Code*, the CITY’s maximum indebtedness for all products and services under this Contract shall be a fixed monetary amount not-to-exceed SIXTY THOUSAND AND 00/100 DOLLARS (\$60,000.00).”

4. Add, attach, and incorporate new **Exhibit “B-1”** to and in said Contract.

SAVE AND EXCEPT as expressly amended by this instrument, the provisions, terms, and conditions of said Contract shall remain unchanged and shall continue in full force and effect.


