
Please let this serve as a Letter of Agreement between Weiss, Handler, Angelos & Cornwell, P.A. and Palm Beach County Sheriff's Office for the purpose of legislative and governmental representation in Florida.

Weiss, Handler, Angelos & Cornwell, P.A. will regularly inform Palm Beach County Sheriff's Office of all related activities and will work on projects and issues as directed. We will also be available for attendance at related meetings and will provide any type of reports or updates as determined necessary by Palm Beach County Sheriff's Office. We will take a proactive approach in the tracking and monitoring of all pertinent legislation and work to plan strategies which would benefit Palm Beach County Sheriff's Office.

Palm Beach County Sheriff's Office agrees to contract with Weiss, Handler, Angelos & Cornwell, P.A. for a monthly retainer in the amount of \$4,000.00. We will also seek reimbursement for any expenses incurred on behalf of Palm Beach County Sheriff's Office. These expenses include long distance phone, fax and copying charges, and reasonable entertainment expenses.
