FSU SGA LOBBYIST SERVICES CONTRACT**

THIS RENEWAL (“Renewal”) of ITN 5864-A (the “Contract”) is made as of the Effective Date by and between **Florida State University Board of Trustees**, a public body corporate of the State of Florida, acting for and on behalf of Florida State University, whose address is 222 S. Copeland Avenue, Westcott Building – Suite 211, Tallahassee, Florida 32306-1480 (hereinafter “FSU”) and **Pittman Law Group, P.L.** (hereinafter “Contractor”), a firm authorized to do business in the State of Florida, whose address is 1028 East Park Ave., Tallahassee, FL 32301. Any addenda underlying this Renewal are attached hereto and are incorporated in their entirety by reference herein.

WHEREAS, the Contract was for the purpose of Contractor providing FSU SGA lobbyist services (the “Service”) from October 19, 2017 through June 30, 2019, with two (1) one-year renewal periods available; and

WHEREAS, FSU and Contractor seek to enter into this Renewal for the purpose of renewing/extending the Contract for an additional one-year period;

NOW THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, FSU and Contractor agree as follows:

Effective Date and Term. This Renewal shall be effective on the date signed by both FSU and Contractor (the “Renewal Effective Date”). The Contract Term is hereby renewed/extended from July 1, 2019 through June 30, 2020, unless terminated earlier as provided in the Contract. All terms and conditions of the Contract remain in full force and effect.
