

AMENDMENT No. 1
TO
CONTRACT BETWEEN
COUNTY OF VOLUSIA, FLORIDA
AND
SOUTHERN STRATEGY GROUP, Inc.

This Amendment No. 1 to Contract between County of Volusia, Florida and Southern Strategy Group, Inc. made and entered into by and between the County of Volusia, a body corporate and politic and a political subdivision of the State of Florida ("County"), and Southern Strategy Group, Inc. a Florida corporation, with a principal place of business at 123 S. Adams Street, Tallahassee, FL. 32302 (hereinafter "Consultant").

Recitals

WHEREAS, on November 1, 2018, the County and the Consultant entered into an agreement under which Consultant agreed to provide state government lobbyist services with an initial term of November 1, 2018, through October 31, 2019 ("Contract"); and

WHEREAS, the County and the Consultant desire to amend the Contract through this Amendment No. 1 by extending the contract through October 31, 2020, and change the name from Southern Strategy Group, Inc. to The Southern Group of Florida, Inc.

NOW THEREFORE, in consideration of the foregoing recitals which are incorporated herein by reference, and other specific consideration set forth in this Amendment No. 1, the receipt and sufficiency of which is acknowledged by the Consultant and County, the parties agree to amend the Contract as follows:

1. The parties agree that the foregoing recitals are true, correct and material to this Amendment No. 1
2. The parties agree to extend the current Contract through Amendment No. 1, through October 31, 2020.
3. The parties agree to the name change from Southern Strategy Group, Inc. to The Southern Group of Florida, Inc. retaining the same address, and federal ID number.
4. This Amendment No. 1, sets forth the entire modification to the Contract with respect to the services provided under this Amendment No.1, unless the Contract is otherwise amended or modified, and supersedes all prior proposals, agreements, and communications, both written and oral.

5. This Amendment No. 1 is incorporated by reference into the Contract as if fully set forth therein. Except as provided herein, all other terms and conditions of the Contract shall remain unchanged and in full force and effect and are hereby ratified and reaffirmed by the parties hereto.
